I recognize that if RCSC accepts my application, this document will become a binding contract, and that my Membership application is subject to my payment of the Member Share and a satisfactory review of my driver's licence and driving record.

- \$35.00 non-refundable Activation Fee (per credit card billed)
- Valid credit card number OR a \$500 deposit in lieu of a credit card
- Copy of valid driver's licence
- Driver Abstract from SGI and/or previous driver's licence provider to a minimum of a 2-year history

Driving Agreement

I have read and understand the Bylaws of RCSC and the RCSC Policy Manual.

I agree to observe and be bound by the Bylaws and Policy Manual including any amendments to either document. They form part of this contract. I recognize that the RCSC Board of Directors may amend the Policy Manual and that Members of RCSC may amend the Bylaws. I agree that it is my responsibility to inform myself of any amendments to the Bylaws and Policy Manual and govern my use and operation of Co-operative Vehicles accordingly.

If my application is accepted, RCSC will, subject to all terms and conditions in the Policy Manual and this application, provide me with access to vehicles owned or rented by it ("Co-operative Vehicles") and pay for related expenses such as gas, tires, maintenance and certain repairs of Co-operative Vehicles

I understand that RCSC will endeavour to ensure vehicles are clean, reliable and well maintained. I, however, recognize that:

- Members share responsibility for the maintenance and safety of Co-operative Vehicles;

- RCSC's periodic inspection of vehicles is supplementary to the inspection of vehicles by Members;
- As a Member I will be responsible for ensuring the safe condition of any Co-operative Vehicle that I drive;
- To the best of my ability I will report to the Co-operative any defect arising during my operation of any Co-operative Vehicle or that I otherwise detect in its condition or operation while the vehicle is in my possession;
- RCSC does not make any representations or warranties as to the fitness or condition of any Co-operative Vehicle.

I recognize that the Policy Manual and Bylaws state when I will be responsible for paying various fees, expenses, liens, and fines. I agree this money will be a debt due and payable to RCSC and that RCSC will have a lien on my Member Share and any paid deposit to cover the full amount owing.

I understand that RCSC will ensure that Co-operative Vehicles are insured under a comprehensive insurance policy, the details of which are available from RCSC. I recognize that RCSC will be liable to me only for any damages arising from my use of a Co-operative Vehicle if RCSC's gross negligence has caused damages. I waive any right I have to sue or make claims against RCSC and its Directors, officers, employees or Members for damages arising from the fitness or condition of a Co-operative Vehicle, except in cases of gross negligence. I also waive my right I have to sue or make claims against RCSC and its Directors, officers, employees or Members for a Co-operative Vehicle not being available at the time it is booked.

I recognize that I, a Member, am not a representative, agent or employee of RCSC except in the case that the RCSC Board of Directors have empowered me to act as a representative, agent or employee.

I understand that if I terminate my Membership during my first six months of fully paying for Membership, RCSC is not required to refund my Member Share until six months after I have become a Member or 90 days after I terminate my Membership, whichever comes later. If I terminate my Membership after the first six months of Membership, RCSC will refund my Member Share within 90 days of termination. In either case, RCSC will only refund that portion of my Member Share and deposit (if any) remaining after deductions for money owing to RCSC.
